

Through this document, I DECLARE:

1. That I have read and fully accept the regulations of the sporting events organized by KLASSMARK. These regulations can be found on the official website: www.klassmark.com.
2. That I am confident I am physically and mentally prepared to participate in the event. I follow adequate medical check-ups to ensure I am in good health and do not suffer from any illness, allergy, physical defect, injury, or cardiorespiratory condition that could advise against my participation.
3. That I am fully aware of the difficulty of the event, including its route, profile, and distance, all of which I have consulted beforehand on the event's website.
4. That I am aware that this type of event carries risks for participants. Therefore, I attend voluntarily and at my own responsibility, fully assuming the risks and consequences derived from my participation. I hereby release the organization, collaborators, sponsors, and other participants from any liability for any physical or material damage that may occur to me. Consequently, I waive the right to file any claim or lawsuit against them.
5. That the owners of the lands, mountains, and estates through which the race takes place are not liable in the event of accidents and are exempt from responsibility.
6. That I have the knowledge and technical skills necessary to ensure my own safety, taking into account the natural environment and the autonomous conditions of the event.
7. That I have the required sporting and safety equipment as specified in the event regulations. I guarantee that my equipment is in good condition, that I know how to use it properly, and that I will carry it with me throughout the event.
8. That I commit to following the safety rules and protocols established by the organization, as well as maintaining responsible behavior that does not increase risks to my physical or mental integrity. I will follow the instructions and respect the decisions made by the organizers (judges, medical staff, and organizers).
9. That I authorize the Medical Services of the event to provide me with any care or diagnostic tests they deem necessary at any point during the event, whether I have requested it or not. If required, I commit to withdrawing from the event and allowing hospitalization if deemed necessary for my health.
10. That I authorize the event organizers to capture and use any photographs, recordings, or footage related exclusively to my participation in this event, without receiving any compensation in return.
11. That I will not consume prohibited substances before or during the event, as defined as doping by the cycling and mountain federations. The organization reserves the right to conduct anti-doping tests on any participant.
12. That I am aware that my race bib is personal and non-transferable, and I will not transfer or sell it to any other person, even if I am unable to attend the event.
13. That the owners of the paths used for the event are not liable for any incident, damage, or injury that may occur. The organizers exempt the property owners from any responsibility associated with the use of these paths.
14. That I commit to following the general guidelines for respecting others and the environment, as outlined below:
 - a) Moving prudently and following traffic rules on open tracks and roads.
 - b) Slowing down in the presence of people, animals, or vehicles.
 - c) Avoiding disruptions to the processes and natural functioning of ecosystems.
 - d) Not damaging biotic, geological, cultural, or other environmental resources.
 - e) Avoiding environmentally sensitive areas.
 - f) Conducting physiological needs in appropriate areas, or at least away from water points and far from paths or gathering areas.
 - g) Not lighting fires or creating situations that pose a fire risk.
 - h) Not using or installing any structure or element that leaves a permanent mark on the environment.
 - i) Not throwing or abandoning solid or liquid waste outside the areas designated for its collection.
 - j) Not leaving the marked route.
 - k) Closing gates or livestock fences that I may need to open to pass through.
15. That I am aware that it is mandatory to have medical insurance to participate in any event organized by Klassmark. This can be a private medical insurance policy that covers this type of sporting event, which the participant declares to have through the registration form, or the insurance offered by the organization, which can be contracted during the registration process. No participant can take part in the event without insurance.
16. That, in the case of having private medical insurance, I commit to going to the medical center corresponding to my policy so that the claim can be properly processed by my insurance company. I will also present my policy upon arrival at the medical center to facilitate the procedure.
17. That I have been informed about the main coverages included in the personal accident insurance contracted through Klassmark.
