



## **PARTICIPANT DECLARATION**

The undersigned person (name and surname) .....: with ID card/passport .....: who is participating in the LABA GRAVEL event on 31 May 2025, declares:

- ✓ That I am aware of the rules of the LABA GRAVEL 2025 event and accept them in their entirety.
- ✓ That I am aware that the event is an individual excursion where any competition is excluded.
- ✓ That I know that the route runs on public roads open to traffic.
- ✓ That I accept the inherent risks involved in the traffic and the route of the event.
- ✓ That I undertake to comply with the rules of the Road Safety Act and its regulations, ensuring my safety.
- ✓ That I exempt the organisers of LABA GRAVEL, and/or any natural or legal person linked to the organisation of the event from the responsibilities derived from any accident caused by reasons related to traffic or sporting accidents.
- ✓ That I exempt the organisers of LABA GRAVEL from any damage that, for health reasons, may arise from my participation in this route, personally assuming the inherent risk for my health that the physical effort required to participate in this event entails.
- ✓ I know that LABA GRAVEL is organised without an ambulance; that it passes through some inhospitable places with difficult access and without mobile coverage where it can be difficult to detect an accident. I know that cycling at night and without sunshine can complicate the detection of accidents and complicate their rescue. I therefore exempt the organisation from any legal responsibility for the detection and rescue of the accident victim.
- ✓ That I accept and know that no crossings are regulated or signposted by the organisation and that all types of vehicles may enter.
- ✓ That the route passes through natural areas of which I undertake to respect the rules such as not littering, not damaging the space, respecting the flora and fauna, not leaving the route given for the organisation and respecting other users of the park.
- ✓ That there may be sections in which the state of the roads is not in adequate safety conditions and excludes the organisation from liability for any damage that I may suffer due to poor road surface maintenance or as a result of defects in the road infrastructure or the roads on which I ride.
- ✓ That there is the possibility of suffering a sporting accident linked to the practice of cycling, assuming personally the responsibility for the accidents that a participant may cause, excluding the organisation from any responsibility derived from these accidents.
- ✓ That there is a possibility of causing an accident to a third person not involved in the route, assuming full personal responsibility for said accident and excluding the organisation from any liability arising therefrom.
- ✓ That I have the day insurance.



## **RIGHT TO IMAGE**

I authorise the organisation to record all or part of my participation in the same, I agree that my image and my geolocation data may be used for the promotion and dissemination of the image of the route in all its forms (radio, press, video, photo, DVD, internet, posters, media, etc.) and I cede all rights relating to its commercial and advertising exploitation that I consider appropriate to execute, without the right on my part to receive any financial compensation whatsoever.

## **LOPD AND POLICY**

The organisation guarantees full compliance with the regulations on Personal Data Protection and, therefore, in accordance with Organic Law 15/1999, the participant is informed and gives his/her consent to the incorporation of his/her data into the organisation's existing automated files and the processing of the same for use in relation to the execution of administrative, commercial and other activities of the organisation. With regard to the privacy policy, the organisation assures the participant, in any case, the exercise of the rights of access, rectification, cancellation and opposition, in the terms established in the current legislation, by writing to the organisation, being responsible for the file with address for these purposes at the address indicated above. The participant accepts that his/her data may be transferred exclusively for activities necessary for the correct execution of the internal management and administration of the Organiser. Likewise, the participant accepts that the Organiser may send him/her information about news, procedures or services that affect the event. The participant's acceptance that their data may be processed or transferred in the manner described in this paragraph is always revocable, without retroactive effect, as provided for in articles 6 and 11 of Organic Law 15/1999 of 13 December.
